

PROGRAMME SPECIFICATION

This document describes the **Joint Honours Degree programme in French and History, German and History, and History and Spanish**. For Joint and Combined Honours Degree programmes, please also refer to the equivalent document(s) for the other subject(s). This specification is valid for new entrants from **September 2015**.

These three Joint Degrees' principal aim is to allow students to pursue the study of specific Modern European Languages alongside that of History, placing European language, literature and culture in an historical context as well as achieving an understanding of historical developments enhanced by the insights provided through the study of the individual countries concerned, plus a year spent abroad in the specified country. In meeting this principal aim the programme also:

- Provides a systematic understanding and knowledge of a Modern European language, literature and culture in an historical context;
- Encourages a critical awareness of the country studied, in terms of both their contemporary complexities and their historical bases;
- Provides insights relevant to the development and interpretation History and country studied and to the evaluation of current research and scholarship in the fields;
- Fosters an independent learning ability for continued intellectual development;
- Provides an opportunity for students to obtain an undergraduate qualification in History and a Modern European Language.

The programme is normally delivered in four stages. The first, second and fourth years each of which comprises one year of full-time study during which the student must follow courses to the value of four units (one unit is equivalent to 30 national credits). The third year taken overseas, must comprise the equivalent of a full year of study overseas, is worth one unit to the degree (the thirteenth unit of the degree, which is added to the four units in the final year for calculating degree classification). The programme comprises 'core' disciplinary courses, including a compulsory stage one common to all degree programmes in the departments, and 'optional' specialist courses, with an extended essay in the final stage. Whilst the development of disciplinary-specific skills are emphasised in the 'core' courses, the specialist options provide focused opportunities to examine the application of these skills. Moreover, the multi-disciplinary common first year, and the opportunity to take courses offered in complementary disciplines gives a heightened appreciation of disciplinary distinctiveness.

Learning outcomes

Teaching and learning on the programme are closely informed by the active research of staff. In general terms, the programmes provide opportunities for students to develop and demonstrate the following learning outcomes:

Knowledge and Understanding

- Extensive knowledge and critical understanding of recent and current developments in the fields of History, and the language, literature and culture of the country studied
- A sound knowledge of the theories, techniques and concepts used to further our understanding of the issues, processes and phenomena associated with the fields of History and Modern European Languages.
- A critical understanding of data relating to the fields of History Modern European Languages and of the results of analysis based thereon.

Skills and other attributes

The Programme is designed to allow students to acquire competence in the following range of discipline-specific and transferable (denoted with an asterisk*) skills:

- Assess the merits of theories, models and explanations in History and Modern Languages and situate them in a wider disciplinary context.
- Apply the concepts and methods used in History and Modern Languages to the analysis of the studied country/countries.
- Evaluate current research and scholarship in the field, and evaluate and, where appropriate, develop critiques of the methodologies employed by historians and modern language scholars.
- Gather, organise and deploy evidence, data and information from a variety of sources, and assess their nature and value.
- Carry out an independent investigation of a modern language and/or historical topic or issue and produce a coherent written account.
- Communicate complex ideas and present arguments and complex information in a clear and concise manner in writing.*
- Analyse and interpret complex issues, and develop reasoned arguments and make sound, critical judgements in the absence of complete data.*
- Use literature, internet and database searches to gain necessary information.*
- Develop the intellectual autonomy and self-direction needed for independent investigation of intellectual problems, taking responsibility for one's learning, and developing habits of reflection on that learning.*
- Exercise of initiative and personal responsibility.*
- Ability to take decisions in complex and uncertain situations.*
- The ability to work autonomously and collaboratively with other.*
- Self-awareness and self-management of research.*
- Awareness of one's responsibility as a local, national and international citizen.*
- Ability to learn independently and to take advantage of life-learning.*
- Skills of oral presentation.*
- Develop an advanced knowledge of the Modern European Language studied*, and of the culture and literature of the country/counties studied.

Teaching and Learning

Teaching and learning on the Programme provides students with a knowledge of the literatures and cultures of various language areas, and to conduct historical scholarship. It is also very strongly informed by the current research interests of the teaching staff from the History Department and the School of Modern Languages, Literature and Culture (SMLLC) contributing courses to these Programmes. This is particularly the case with the 2nd and 4th Year options, all of which are offered by staff based on their own individual research interests (fully consistent with the College's approach to Research led Teaching).

The main methods used to develop knowledge and understanding are: formal lectures by academic staff, tutorials and seminar discussions based on a combination of staff led sessions and student participation (including presentations). There is also guided independent research and study for the 4th Year Dissertation.

Assessment will be by a combination of assessed coursework and examination as indicated in individual Course Specifications. Full details of the assessments for individual courses can be obtained from the [Department](#).

Details of the programme structure

Please note that not all courses run each year. A full list of courses including optional courses for the current academic year can be obtained from the [Department](#).

The Programme is designed to be completed in 4 years of full-time study. Students complete 13 full units. Each of the three degree programmes rely on an equal division of courses between the relevant Department in the School of Modern Languages and the Department of History, 2 units (or equivalents) from the School of Modern Languages, Literature and Culture (SMLLC), 2 units (or equivalents) from the Department of History.

Stage One

Students must take the following **mandatory** courses in History:

HS1002 History and Meanings (0.5 unit)

HS1005 Public History (0.5 unit)

Students **must** also take one Gateway whole unit course from the Department of History.

Stage Two:

Students **must** take the following course from the Department of History:

HS2300 Independent Essay of 5,000 Words (0.5 unit)

This essay is freestanding. The subject of the essay must be outside the direct remit of the various Group 1 taught courses in the Department of History, and taught courses from the SMLLC, that the student is taking. Work on the essay takes place in Term One and Term Two.

It is also recommended that students take HS2301 as an extra-curricular course. This course offers invaluable assistance in planning and writing a dissertation.

In addition, students must take three of the Group 1 half unit courses.

In Term One students must take three Group 1 half unit courses, with at least one coming from each of two baskets (A & B)

HS2224 Spain from Dictatorship to Democracy, 1939-1989 (0.5 unit)

Stage Three

This is an extra-curricular year, taken at one of the EU-partner University of either the Department of History or the School of Modern Languages in France, Germany or Spain (depending on Degree registration); at a Latin American University (for History and Spanish), with the specific agreement of the Department of History. Students are required to take a year of academic study at their assigned overseas University, equivalent to a full-time load that a degree-seeking student would take at that institution. The grades achieved overseas will be averaged, and added to the Royal Holloway degree programme as a thirteenth unit (HS3400), which will be counted as a final year unit when the final degree classification is calculated.

All first year students on single joint or combined honours programmes offered all or in part by departments or schools in the Faculty of Arts & Social Science are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the [College's Undergraduate Regulations](#) (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.

The administration of the year abroad will be undertaken by the School of Modern Languages, Literature and Culture (SMLLC), in consultation with the Tutor for International Studies (Erasmus Programmes) in the Department of History. The programme of study overseas will have to be approved by both the Department and the School. Stage Four

Students **must** take the following courses in the Department of History:

One Group 3 course (taught course and Dissertation) from the available History options (2 units).

The optional course will vary from year to year and the full list of those available will be promulgated prior to the commencement of each academic session.

Progression and award requirements

The progression and award requirements are essentially the same across all Honours Degree programmes at Royal Holloway as outlined in the College's Undergraduate Regulations. Students must pass units to the value of at least three units on each stage of the programme. Failing marks of 30 – 39% can normally be condoned in up to 30 credits across stages 1 and 2. In the final stage failing marks in up to 30 credits can normally be condoned. However, on some programmes there may be a requirement to pass specific courses in order to progress to the next stage or to qualify for a particular degree title and this will put restrictions on courses in which failing marks can be condoned (see programme structure above for details). Additionally there are requirements on the number of courses that must be passed in order to qualify for particular joint or combined Honours degrees.

Students are considered for the award and classified on the basis of a weighted average. This is calculated from marks gained in courses taken in stages two and three, and gives twice the weighting to marks gained in stage three. The College's Undergraduate Regulations include full details on progression and award requirements for all undergraduate programmes offered by the College.

Student support and guidance

- Personal Advisers: All students are allocated a personal adviser in each department who meets with them in the induction week and then regularly through the programme. The tutor's role is to advise on academic, pastoral and welfare issues.
- All tutors and academic staff, including the Head of Department, are available for consultation at advertised office hours.
- The Departmental Academic Coordinator provides guidance and advice on a range of academic, administrative, pastoral and welfare matters.
- The Department operates an 'open door' policy such that any member of staff may be consulted by students.
- Induction programme to the Department and College for orientation at the start of the first year.
- Detailed and comprehensive Departmental Student Handbook.
- The Departmental Staff/Student Committee acts as a channel of communication between staff and students.
- Extensive supporting material and learning resources available from the College libraries. In addition students also have access to a wide range of resources available through other University of London libraries.
- College Careers and Employability Service and Departmental Careers and Employability Tutor.
- Access to all College and University support services, including Student Counselling Service, Health Centre and the Disability and Dyslexia Services for students with disabilities and Specific Learning Difficulties.

Indicators of quality and standards

Royal Holloway's position as one of the UK's leading research-intensive institutions was confirmed by the results of the most recent Research Excellence Framework (REF 2014) conducted by the Higher Education Funding Council (HEFCE). The scoring system for the REF 2014 measures research quality in four categories, with the top score of 4* indicating quality that is world-leading and of the highest standards in terms of originality, significance and rigour and 3* indicating research that is internationally excellent. 81% of the College's research profile was deemed to be within the 4* or 3* categories, an increase of over 20% since 2008. This result placed Royal Holloway 31st overall in the UK for 4* and 3* research and 33rd based on an overall Grade Point Average (GPA) score.

The Department of History is ranked 26th in the UK for research of 4* standard and 38th for 3* and 4* research.
