**Course specification for an undergraduate award**  
**BA Drama with Film (W4W6)**

**Section 1 – Introduction to your course**

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Your degree course in Drama with Film is delivered in three stages, each of which normally comprises one year of full-time study, during which you must follow modules to the value of 120 credits.

At **first year**, you will be introduced to the discipline of Drama, Theatre, and Dance (by way of the foundation modules DT1100 Theatre and Performance Making 1 and DT1200 Theatre and Text 1) and the discipline of Film Studies (by way of MA1054 Introduction to Narrative and MA1154 Screen Narrative: Theory and Practice). You will work on foundation departmental modules in your first year before beginning your collaborative work in second year.

In the **second year** you will take the joint module, Acting for Camera, where you will investigate the application of stage acting techniques to screen acting techniques. You will collaborate with second year Directing students in Media Arts to create short films. Acting for Camera is supported by the 15 credit module, DT2402 The Idea of Acting, where acting histories and traditions will be explored in theory. You must take 2 x 15 credit theory modules OR 1 x 30 credit practice module in Media Arts to develop a broader critical understanding of film, developing an appreciation of a range of traditions of film form. In addition, you will also have the opportunity to choose modules in either department depending on your interests/curiosities. This allows you to create your own unique module-load during the degree course.

As **third years**, you will have further autonomy over the modules you choose and work you create. You are required to work on DT3202 Group Performance, working collaboratively on performance projects with the entire Drama, Theatre, and Dance cohort and guided by shared interests in performance making. These interests may include creating a film or live performance with media. Alongside developing your understanding and appreciation of film and media form in 2 x 15 credit Media Arts theory options OR 1 x 30 credit Media Arts practice option and be able to choose from a range of advanced options in from the Department of Drama, Theatre, and Dance, further contributing to your individualised learning. You will also undertake an independent research project in your final spring term, creating either a dissertation or special project within the Drama, Theatre, and Dance Department. This individual project may be informed by your work in Media Arts, for example a dissertation about film/media or a mediated special project, such as a film or an App.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

*Degree course* – May also be referred to as ‘degree programme’ or simply ‘programme’, these terms refer to the qualification you will be awarded upon successful completion of your studies.

*Module* – May also be referred to as ‘course’, this refers to the individual units you will study each year to complete your degree course. Undergraduate degrees at Royal Holloway comprise a combination of modules in multiples of 15 credits to the value of 120 credits per year. On some degree courses a certain number of optional modules must be passed for a particular degree title.

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules each year. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module before you can proceed to the next year of your course, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

\*Contact hours come in various different forms, and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff. It is intended that these contact hours will face-to-face as far as possible, but in certain unavoidable situations, these may take place virtually.

\*\*The way in which each module on your degree course is assessed will also vary, however, the assessments listed above are all 'summative', which means you will receive a mark for it which will count towards your overall mark for the module, and potentially your degree classification, depending on your year of study. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module.

### 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can access via their [webpage](#).

In your **final year**, in addition to the mandatory module you must choose from:

**either** 2 x 15 credit theory modules **OR** 1 x 30 practice module from Media Arts, subject to availability

**AND** you must also choose 60 credits worth of modules, which consists of one of the following modules:

DT3201 Dissertation **OR** DT3203 Special Project **OR** DT3104 Taught Dissertation (30 credits)

**AND**

DT31XX Advanced Option (any option) 30 credits or 15 credits.

#### Section 4 - Progressing through each year of your degree course

All first year students on single, joint or combined honours courses offered all or in part by the School of Humanities, School of Performing and Digital Arts, or department of Politics, International Relations and Philosophy are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the [College's Undergraduate Regulations](#) (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.

## Section 5 – Educational aims of the course

The aims of this course are:

- To engage you critically and creatively in the process of making and experiencing drama, theatre and electronically mediated performance.
- To enable you to develop independent critical thinking and judgement;
- To develop and enhance your expression of your ideas in a variety of modes and contexts, including essay writing, film making, and performance making;
- To develop creative writing skills, including screen writing and generating text for live performance
- To foster the appreciation of diverse theatre, performance, film, radio, and television practices from a range of historical and geographical contexts;
- To encourage an awareness of theatre and media's relationship with a wide range of different intellectual and cultural practices and disciplines;
- To foster understanding of the complementary value of critical and creative exploration;
- To encourage you to take progressive responsibility for your own study through negotiating subject areas of specialism with each other in seminars, through the informed choice of options and an extended piece of independent work in the final year.
