**MSCI COMPUTER SCIENCE (ARTIFICIAL INTELLIGENCE) WITH A YEAR IN INDUSTRY (GG74)**

### Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Your degree course in **MSci Computer Science (Artificial Intelligence) with a Year in Industry** provides progressive structures in which you are able to gain ever-wider knowledge and understanding, and appropriate skills. The courses contain a combination of mandatory and elective modules to introduce you to the theory and practice of Computer Science, including software development techniques and the technologies underlying specific application areas such as gaming and robotics.

The structure encourages you to develop your own interests through informed choice among specialist options. In the final stage of the course, you undertake a project, which accounts for 50% of your studies in the final stage. There is a free choice of other penultimate and final stage modules reflecting both core material, such as compiler theory, and currently important research areas such as machine learning, information security, software language engineering, intelligent agents, computational finance and bioinformatics.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

*Degree course* – Also referred to as 'degree module' or simply 'module', these terms refer to the qualification you will be awarded upon successful completion of your studies.

*Module unit* – Also referred to as 'module', this refers to the individual units you will study each year to complete your degree course. Undergraduate degrees at Royal Holloway comprise a combination of modules to the value of 120 credits per year. On some degree courses a certain number of optional modules must be passed for a particular degree title.

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules each year. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module before you can proceed to the next year of your course, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

\*Contact hours come in various different forms, and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be

laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.

\*\*The way in which each module on your degree course is assessed will also vary, however, the assessments listed above are all 'summative', which means you will receive a mark for it which will count towards your overall mark for the module, and potentially your degree classification, depending on your year of study. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module.

### 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the module of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can access via their [webpage](#).

### 3.3 Other module unit requirements

++ You may take CS1813 Software Development instead of CS1812 at the discretion of the department.

+++ You may take CS1821 Programming Fundamentals instead of CS1822 at the discretion of the department.

\*\*\* You cannot take this module if the module with the same title was taken in Year 3.

In **Year 2**: you will take 2 further non-project elective module(s) starting with CS2 from the AI strand.

In **Year 3**: you will take 2 further non-project elective module(s) starting with CS3 or IY3 from the AI strand; and you will take 6 further non-project elective module(s) starting with CS3 or IY3 or PC3001.

In **Year 5**: you will take 2 further non-project elective module(s) starting with CS4 or IY4 from the AI strand; and you will take 2 further non-project elective module(s) starting with CS4 or IY4.

**Note:** students for each year are expected to take part in the Advanced topics seminar module (CS3010). This module is not part of the degree course but attendance will be placed in the student's transcripts.

#### Section 4 - Progressing through each year of your degree course

This module does not carry credit but passing it is a requirement to progress to the next year of study.

##### Year in Industry

Students taking an industrial year take additional module CS4001 and thus have 150 credits in their final year.

Students on degree courses with Year in Industry need to fulfil the requirements set out in the departmental Year in Industry Handbook in order to progress to the placement and be eligible for the degree title.

#### Section 5 – Educational aims of the course

The aims of this course are:

- to produce graduates with the ability to engage in the lifelong learning and with the skills required for a professional career in a computer-based environment or for a research career in Computer Science and related areas;
- to develop a mastery of computing-related cognitive abilities and skills as described in the QAA Computer Science benchmark statement;
- in a flexible and progressive structure, to develop students' knowledge and understanding of essential facts and theory, with the ability to use this knowledge to devise, specify, design, implement, test, document and critically evaluate computer-based systems;
- to develop an advanced understanding of professional and ethical issues involved in the deployment of computer technology;
- to produce graduates with a range of personal attributes relevant to the world beyond higher education, including information retrieval and use, numeracy, the ability to devise and present logical arguments to inform and support actions, and organisational skills;
- to develop an advanced understanding of knowledge and current awareness of current problems and/or new insights in the area of computing science research.

<ul style="list-style-type: none"> <li>• an advanced knowledge and understanding of the facts, concepts, principles and theories relating to computing and computer applications (K);</li> <li>• mastery of the implications of recent research in Computer Science, artificial intelligence and related fields, and how such research results can be incorporated into computer-based systems (K);</li> <li>• a command of the professional, moral and ethical aspects of the use of computer-based systems, and ability to recognise any risks or safety aspects in a given context (K);</li> <li>• knowledge of how computers are programmed and used; advanced programming; software engineering and team work for developing a significant software system; the fundamental technologies used for artificial intelligence; the functioning of the Internet and the World Wide Web; the main concepts of database technology and design; background theory necessary for a deeper understanding of computing and computers (K);</li> <li>• depending on their course of studies, students may also gain a knowledge of the following key practical application technologies: operating systems; graphics; robotics, bioinformatics, information security, applied artificial intelligence and human-computer interfaces; theoretical foundations of algorithms and programming (K);</li> <li>• appreciation of the importance of computing and information technology for commerce and industry and an understanding of expected industry changes and the effects they will have (K);</li> <li>• ability to deploy appropriate theory, practices and tools for the modelling, specification, design, implementation and evaluation of computer-based systems (including stand-alone computer systems, information systems, embedded systems, distributed systems and web-based systems) to meet given requirements under practical constraints (S);</li> <li>• employ the research skills needed to investigate a defined topic under supervision, through an extended individual project (S);</li> </ul>	<ul style="list-style-type: none"> <li>• interpersonal skills, including the ability to work as a member of a development team, recognising/respecting the viewpoints of others, recognising the different roles within a team and the different ways of organising teams (S*);</li> <li>• problem identification, analysis and solution using critical assessment and reasoned argument (S*);</li> <li>• taking responsibility for own learning and developing habits of reflection on that learning (S*);</li> <li>• skills in written communication, project documentation, verbal presentation; numeracy and computation (S*);</li> <li>• use of information technology (including spreadsheets, databases, word processing, email and WWW) (S*);</li> <li>• information handling and retrieval (including the use of libraries and computer technology) (S*);</li> <li>• ability to work autonomously, and to demonstrate time management and organisational skills (S*);</li> <li>• ability to apply knowledge and skills in computing to large-scale practical applications (S);</li> </ul>

<p>Teaching and learning is mostly by means of lectures, small-group tutorials, practical and problem classes, supervised computing laboratory work, group work, completion of coursework and private study, guided independent study and research in the stage three individual project.</p> <p>Assessment of knowledge and understanding is typically by formal, unseen written examination, coursework assignments, project reports, oral presentations, and the final stage project report. Transferable skills are also inherently assessed through the assignments, reports and oral presentations. Feedback is provided on students' performance in coursework, both assessed and non-assessed, and during tutorial and practical sessions.
