

# Late Antique and Byzantine Studies; MA; 1250 September 2017 intake

The purpose of this information sheet is to provide prospective students and applicants with further information about the nature of the degree, in order to help you decide if it is the right choice for you. ## Section 1 – degree programme structure

Standard length of degree	One year (Full Time)
Available part-time	Yes – Two years

This is a University of London intercollegiate programme taught jointly with King's College London (KCL), University College London (UCL) and Birkbeck College (BBK), University of London. In choosing where to register, students should note that they will normally be expected to undertake their dissertation at their home College: they should therefore aim to register at the College where staff interests are closest to their own.

Taught over one year (full-time) or two years (part-time), it is designed especially for those who are interested in progressing to doctoral research in Late Antique and Byzantine studies. It also aims to relate the history of Late Antiquity and Byzantium to the wider world.

The following table summarises the compulsory modules, which are referred to by Royal Holloway as mandatory course units, offered on this degree programme as well as the optional course units that are likely to be available. Please note that although the College will keep changes to a minimum, new units may be offered or existing units may be withdrawn, for example, in response to a change in staff. You will be informed if any changes need to be made. This programme requires a minimum of 6 students to enable the College to run the course. Should this number not be reached and we are unable to run the programme we will offer an alternative or refund any deposit paid.

Students studying part-time are charged a pro-rata tuition fee and information is available from the Royal Holloway Student Fees Office on <a href="Student-Fees@rhul.ac.uk">Student-Fees@rhul.ac.uk</a>. ### Section 3 - useful vocabulary

We understand some of the terminology used in this document may be new to you, and may differ from that used by other universities. To help with this, we have provided a brief description for some of the most important terminology:

Degree programme – Also referred to as 'degree course' or simply 'course', these terms refer to the qualification you will be awarded upon successful completion of your studies.

<sup>\*\*</sup> These estimated costs relate to studying this particular degree programme at Royal Holloway. Costs, such as accommodation, food, books and other learning materials and printing etc., have not been included, and further information regarding these can be found on our website.



Course unit – Also referred to as 'module', this refers to the individual units you will study each year to complete your degree programme. Masters programmes consist of a number of taught course units – some mandatory and some optional - plus a dissertation/ project to the value of 180 UK credits in total. On completion of a minimum of 120 UK credits a student may be awarded a Postgraduate Diploma, while on completion of a minimum of 60 credits a student may be awarded a Postgraduate Certificate. Some Masters programmes may have progression requirements (where they are offered over more than one year of study) or pass requirements for degree title if they are accredited by a professional body.

*H/EU* – Different categories of students pay different levels of tuition fees. H/EU stands for students with Home or European Union fee status.

*Overseas* – Non-EU students are liable to pay the overseas rate of tuition fees, and are sometimes also referred to as international students.
