

# Royal Holloway, University of London Course specification for a postgraduate award MA in History (2338)

#### Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. This Masters course has been specially devised to provide an advanced level study of the theories and practical skills that underpin the discipline of history. It does so through a mandatory module, studied by all students, which examines key concepts, theories and methodologies. Additionally, students take a skills module which pursues these conceptual questions further in relation to the practical applications of historical research (e.g. media and museums). Finally students also choose a number of Option modules, which cover leading edge research in an array of key fields of Modern, World, European, British and Public History. The Masters course is delivered over one year of full-time study (52 weeks) or up to five years of part-time study (260 weeks). Teaching takes place during the day over two terms from September to March. The dissertation is submitted in September. On successful completion of the course a student should have an understanding of the area of the MA at a level appropriate for a postgraduate qualification. Whilst being a self-contained degree in its own right, the course provides suitable and recognised qualifications for entry to PhD study in the same or a closely related field.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – Also referred to as 'course', this term refers to the qualification you will be awarded upon successful completion of your studies. 'Courses' were formerly known as 'programmes' at Royal Holloway.

Module – This refers to the credits you will study each year to complete your degree course. Postgraduate taught degrees at Royal Holloway comprise 180 credits. On some degree courses a certain number of optional modules must be passed for a particular degree title. 'Modules' were formerly known as 'course units' at Royal Holloway.

## 3.1 Mandatory module information

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module to successfully graduate with a particular degree title, or before you can proceed to the next year of your course where studying part-time. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them (see <u>Academic Regulations</u> on condonable fails). Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

# 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can normally access via Moodle.

## 3.3 Optional module requirements

Subject to the agreement of the Director of the MA in History, students may also choose option courses to a maximum value of 40 credits from a cognate MA within Royal Holloway or from another History MA programme within the University of London (i.e. those courses offered by other London Colleges within the federal basketing system).

# Section 4 - Progressing through each year of your degree course

For further information on the progression and award requirements for your degree, please refer to Royal Holloway's Academic Regulations.

All postgraduate taught students are required to take and pass the non-credit bearing Moodle-based Academic Integrity module SS1001 in order to be awarded. The pass mark for the module assessment is stated in the on-line Academic Integrity Moodle module. Students may attempt the assessment as often as they wish with no penalties or capping. Students who otherwise meet the requirements for award as stipulated in the <u>Academic Taught Regulations</u> but fail to pass the Moodle-based Academic Integrity module will not be awarded.

Progression throughout the year/s is monitored through performance in summative or formative coursework assignments. Please note that if you hold a Tier 4 (General) Student Visa and you choose to leave (or are required to leave because of non-progression) or complete early (before the course end date stated on your CAS), then this will be reported to UKVI.



Full-time MA students will complete the equivalent of 120 credits worth of taught modules in the first two terms, and complete their Dissertation/Final Project in the summer months for submission in early September. Part-time students will normally complete methodology, skills and option modules to the value of 80 credits in the first year of study, and choose more options (to the value of 40 credits) and the Dissertation/Final Project in the second year of study. The brief outline of the course is show in 3.1 and 3.3 above; however you can obtain further details from the Course Handbook and the Director of the MA in History.

You are initially registered under the general title of MA History. Depending on your choice of option modules, you will exit with a specific degree subtitle listed below. If you have related questions, or are unclear about the impact of your option choices on your degree subtitle, you should consult the Director of the MA in History at the earliest opportunity. In order to exit with one of the Exit Awards, one of the option modules taken (from a list supplied by the department, or otherwise agreed with the MA History Course Director) should relate to that specialist area and the dissertation should be on a related topic. Progression throughout the year/s is monitored through performance in oral presentations, contributions to seminar discussion and coursework.

## Section 5 – Educational aims of the course

The aims of this course are to:

- provide advanced study of History from one or more perspectives and time periods including British, European and World history, Gender History, Public History;
- examine critically current knowledge, and the essential concepts and theories that inform the study of History;
- provide the opportunity for advanced study of specialised topics within History that involve the critical assessment of both primary source material and secondary literature;
- examine critically current techniques of enquiry and research in the chosen specialism(s) within History;
- provide applied training in the methodologies and techniques needed for research leading to MPhil/PhD in History and related fields;
- foster the ability to learn independently, whether for further research, for career enhancement or for personal intellectual development;
- develop the written and oral presentation skills needed for effective communication of research findings at postgraduate level.

## Section 7 - Teaching, learning and assessment

Your interest and enthusiasm is nurtured through your close involvement with the current research of established scholars. As befits an advanced research programme, all teaching is highly interactive, with an emphasis on open discussion within a 'community of scholars'. Methods used to develop knowledge and understanding are seminars, discussion groups and student oral presentations. In the mandatory module, assignment sheets are given to you each week to provide suggested reading and advance notice of topics for forthcoming discussion. In the skills modules, teaching involves small groups with presentations from the tutor and/or visiting speakers and/or weekly reports from students. Option classes are taught on the basis of themes intensively prepared by students themselves and then debated collectively with the group and the tutor.

Discipline-specific and transferable skills are developed throughout the course by means of group discussion; a range of other participative activities (e.g. short student papers; the reciprocal pre-circulation of discussion points by all students in a class) and by guided independent research or study. All modules will contribute to the acquisition of these skills but the mandatory module in Modern History and the Dissertation are particularly important in this respect. Research skills are developed to a professional level through the design and production of the independent research dissertation, which also serves to integrate knowledge and skills acquired throughout the course.

Assessment of knowledge, understanding and skills is by coursework essays, by other related coursework as appropriate (e.g. skills project) and by independent dissertation. The assessment methods used for a particular module will vary in accordance with the knowledge and skills being developed by that module. Full details of the assessments for individual modules can be obtained from the <u>Department</u>.

There are no single associated costs greater than £50 per item on this degree course.
