

# Royal Holloway, University of London Programme specification for an undergraduate award BA Politics and International Relations (L290)

## Section 1 - Introduction to your programme

This programme specification is a formal document, which provides a summary of the main features of your programme and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Your degree programme in Politics and International Relations is normally delivered in three stages, each of which comprises one year of full-time study during which you must follow courses to the value of 120 credits. The programme comprises mandatory disciplinary courses and 'optional' specialist courses, with an extended essay in the final stage. Whilst the development of disciplinary-specific skills are emphasised in the mandatory courses, the specialist options provide focused opportunities to examine the application of these skills. Moreover, the multi-disciplinary common first year, and the opportunity to take courses offered in complementary disciplines, gives a heightened appreciation of disciplinary distinctiveness.

While Royal Holloway keeps all the information made available under review, programmes and the availability of individual course units, especially optional course units are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific programme. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree programme – Also referred to as 'degree course' or simply 'course', these terms refer to the qualification you will be awarded upon successful completion of your studies. Course unit – Also referred to as 'module', this refers to the individual units you will study each year to complete your degree programme. Undergraduate degrees at Royal Holloway comprise four full units, or a combination of full and half units, to the value of 120 credits per year. On some degree programmes a certain number of optional course units must be passed for a particular degree title.

This table sets out the most important information for the mandatory courses on your degree programme. These courses are central to achieving your learning outcomes, so they are compulsory, and all students on your degree programme will be required to take them. You will be automatically registered for these courses each year. Mandatory courses fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) courses, you must pass the course before you can proceed to the next year of your programme, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) courses, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree programme may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and programme requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

\*Contact hours come in various different forms, and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.



\*\*The way in which each course on your degree programme is assessed will also vary, however, the assessments listed above are all 'summative', which means you will receive a mark for it which will count towards your overall mark for the course, and potentially your degree classification, depending on your year of study. On successful completion of the course you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular course.

#### 3.2 Optional course units

In addition to mandatory course units, there will be a number of optional course units available during the course of your degree. The following table lists a selection of optional course units that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and programme requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can access via their webpage.

### 3.3 Optional course unit requirements

In your second year, you must take:

Either

PR2490 Contemporary Political Theory (30 credits) and at least 30 credits from the options available in International Relations

PR2440 International Relations Theory (30 credits) and at least 30 credits from the options available in Politics.

**plus** a further 30 credits of appropriate Stage Two courses in Politics and International Relations.

In your third year, depending on what topic is selected for PR<sub>3</sub>000, you must choose options to the value of 90 credits from available Stage Three options in order to ensure that you take options to the value of 60 credits in Politics and 60 credits in International Relations.



## Section 4 - Progressing through each year of your degree programme

For further information on the progression and award requirements for your degree, please refer to Royal Holloway's <u>Academic Regulations</u>.

All first year students on single, joint or combined honours programmes offered all or in part by departments or schools in the Faculty of Arts & Social Science are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the <u>College's Undergraduate Regulations</u> (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.

All second year students on single, joint or combined honours programmes for which the Department of Politics and International Relations is the lead department are also required to undertake and pass a short 'reflecting on feedback' exercise in order to progress into the final year of study. Students undertaking this exercise will be supported by their personal tutor and will be marked on a pass/fail basis. Students who fail the exercise will have an opportunity to resubmit. Students who meet the requirements for progression as stipulated in the <u>College's Undergraduate Regulations</u> (Section: Conditions for progression to the next stage) but fail to pass 'reflecting on feedback' exercise will not be permitted to progress into their final year of academic study at the College.

## Programmes including an International Year

You must take courses at an overseas university nominated through the Erasmus or Student Exchange Programmes. The equivalent of a full academic load at the overseas university must be taken. The courses to be taken overseas are to be agreed with the Tutor for International Studies in the Department. The marks achieved are converted into equivalent College marks and count as a thirteenth unit. This will contribute 20% to the final stage three marks.

## Section 5 – Educational aims of the programme

The aims of this programme are:

- Provides a systematic understanding and knowledge of political theory and institutions in both a domestic and international context
- Encourages critical awareness of current political problems at national and international levels
- Provides theoretical insights and methodological techniques relevant to the development and interpretation of knowledge in Politics and International Relations and to the evaluation of current research and scholarship in the field
- Fosters an independent learning ability for continued intellectual development



#### Section 6 - Programme learning outcomes

In general terms, the programmes provide opportunities for students to develop and demonstrate the following learning outcomes. (Categories – Knowledge and understanding (K), Skills and other attributes (S), and Transferable skills (\*))

- 1. Extensive knowledge and critical understanding of recent and current developments in the field of political science and international relations, and of the issues and controversies associated with these developments (K);
- 2. A sound basic understanding of social science and international relations methodology **(K)**;
- 3. A critical understanding of result and data relating to the field of political science (K);
- 4. Familiarity with a broad selection of the principal classic and contemporary texts in the fields of politics and international relations (K);
- 5. A sound knowledge of the theories, techniques and concepts used to further our understanding of the issues, processes and phenomena associated with the field of politics and international relations (K);
- 6. A sound understanding of the principal approaches and current issues in a range of options taught during the second and third years of the programme (K);
- 7. Assess the merits of theories, models and explanations in political science, and situate them in a wider disciplinary context (S);
- 8. Apply the concepts and methods used in political science and international relations to the analysis of political theories and institutions within the international system (S);
- 9. Analyse qualitative and quantitative data relating to the field of politics and international relations (S);
- Evaluate current research and scholarship in the field, and evaluate and, where appropriate, develop critiques of the methodologies employed by political scientists (S);

- 11. Gather, organise and deploy evidence, data and information from a variety of sources, and assess their nature and value (S);
- 12. Carry out an independent investigation of a political topic or issue and produce a coherent written account (S);
- 13. Communicate complex ideas and present arguments and complex information in a clear and concise manner in writing (S\*);
- 14. Analyse and interpret complex issues, and develop reasoned arguments and make sound, critical judgements in the absence of complete data (S\*);
- 15. Use literature, internet and database searches to gain necessary information (S\*);
- 16. Develop the intellectual autonomy and self-direction needed for independent investigation of intellectual problems, taking responsibility for one's learning, and developing habits of reflection on that learning (S\*);
- 17. Exercise of initiative and personal responsibility (S\*);
- 18. Ability to take decisions in complex and uncertain situations (S\*);
- 19. The ability to work autonomously and collaboratively with others (S\*);
- 20. Self-awareness and self-management of research (S\*);
- 21. Awareness of one's responsibility as a local, national and international citizen (S\*);
- 22. Ability to learn independently and to take advantage of life-learning (S\*);
- 23. Skills of oral presentation (S\*);



### Section 7 - Teaching, learning and assessment

Teaching and learning on the programmes draw on the methods and concepts used to investigate political phenomena at both national and international levels. It is also strongly informed by the current research interests of the core teaching team within the Department. The main methods used to develop knowledge and understanding are formal lectures by academic staff within the Department, tutorials and seminar discussions based on a combination of staff led sessions and student presentations.

Assessment will be by a combination of assessed coursework and examination, as indicated in individual course specifications. The aim through the programme is to use a variety of different assessments (essays, examinations, other set coursework, presentations) to gauge your performance in as comprehensive a way as possible. In studying Politics and International Relations, the assessment process culminates in guided independent research/study with the production of a dissertation, which is a compulsory course in the final year.

Full details of the assessments for individual courses can be obtained from the Department of Politics and International Relations.
