

Royal Holloway, University of London Programme specification for an undergraduate award BA European and International Studies (Italian) (R300)

Section 1 – Introduction to your programme

This programme specification is a formal document, which provides a summary of the main features of your programme and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Alternatively, further information on the College's academic regulations and polices can be found here. Further information on the College's Admissions Policy can be found here.

Your degree programme in European and International Studies (Italian) is delivered in three stages at Royal Holloway, each of which comprises one year of full-time study during which you must follow courses to the value of 120 credits. European and International Studies is an interdisciplinary, course-unit programme and for each of the language pathways (European and International Studies with French/German/Italian/Spanish) this includes a year abroad between Stages two and three. You spend the year in a country appropriate to your major language option. If you are studying two languages you may, if approved by the relevant department and by the Director of European and International Studies, spend your year abroad in two countries. You take courses to the value of 420 credits overall. This is based on 120 credits in each stage in residence at Royal Holloway and 60 credits based on the year abroad between Stages two and three. For the Politics, Society and Culture pathway, the mandatory language courses are replaced by mandatory literature and culture courses (from a range of options), and you progress directly from the second to the third and final year.

For joint and combined honours programmes, please refer to the programme specification for your secondary department's corresponding single honours programme for further information on educational aims, and learning outcomes.

While Royal Holloway keeps all the information made available under review, programmes and the availability of individual course units, especially optional course units are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific programme. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is a brief description for some of the most important terminology for understanding the content of this document:

Degree programme – Also referred to as 'degree course' or simply 'course', these terms refer to the qualification you will be awarded upon successful completion of your studies.

Course unit – Also referred to as 'module', this refers to the individual units you will study each year to complete your degree programme. Undergraduate degrees at Royal Holloway comprise four full units, or a combination of full and half units, to the value of 120 credits per year. On some degree programmes a certain number of optional course units must be passed for a particular degree title.

3.1 Mandatory course unit information

This table sets out the most important information for the mandatory courses on your degree programme. These courses are central to achieving your learning outcomes, so they are compulsory, and all students on your degree programme will be required to take them. You will be automatically registered for these courses each year. Mandatory courses fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) courses, you must pass the course before you can proceed to the next year of your programme, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) courses, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree programme may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and programme requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

*Contact hours come in various different forms, and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.



**The way in which each course on your degree programme is assessed will also vary, however, the assessments listed above are all 'summative', which means you will receive a mark for it which will count towards your overall mark for the course, and potentially your degree classification, depending on your year of study. On successful completion of the course you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular course.

3.2 Optional course units

In addition to mandatory course units, there will be a number of optional course units available during the course of your degree. The following table lists a selection of optional course units that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and programme requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can access via the Politics and International Relations webpage or School of Modern Languages, Literatures and Cultures webpage.

3.3 Optional course unit requirements

First Year – Italian

You must take:

IT1701 Italian Advanced Written I and IT1702 Italian Advanced Oral I (post A-Level)

Or

IT1601 Italian Ab Initio Written I and IT1602 Italian Ab Initio Oral I (ab initio)

Plus a further 30 credits from Modern Languages.

Second Year - Italian

You must take:



IT2050 Advanced Italian II (post A-Level)

Or

IT2000 Advanced Italian II for Post Beginners (ab initio)

Plus a further 30 credits from Modern Languages.

Third Year – Italian

Students who choose to spend a full year in an Italian speaking country, in addition to ML2999, must take:

IT2501 Oral Examination in Italian (30 credits)

Students who choose to spend half the year in an Italian speaking country and the other half a year in the other country, in addition to ML2999, must take:

IT2502 Oral Examination in Italian (15 credits)

Plus either:

FR2502 Oral Examination in French (15 credits) **OR** GM2502 Oral Examination in German (15 credits) **OR** SN2502 Oral Examination in Spanish (15 credits)

Fourth Year - Italian

In addition to your mandatory course, you choose options equal to the value of 30 credits from a range of Stage four courses offered by the School for students on this programme and specified courses in the other subject.

Students are not permitted to write more than two SMLLC dissertations.

Section 4 - Progressing through each year of your degree programme

For further information on the progression and award requirements for your degree, please refer to Royal Holloway's <u>Academic Regulations</u>.

All first year students on single joint or combined honours programmes offered all or in part by departments or schools in the Faculty of Arts & Social Science are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the <u>College's Undergraduate Regulations</u> (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.

Additional notes on the Period of Residence Abroad



There are three main schemes:

- Italian University: students spend all or part of the academic year following courses of their choice at the host university. In Italy, most students choose a host university which has an Erasmus link with RHUL. Students following Joint Honours, Multilingual Studies and European Studies programmes may choose to spend the year in two countries.
- Assistant post (co-ordinated by the British Council): students are employed to teach English in a school in Italy, normally for up to 12 hours per week. Students are required to produce a written Work Placement Report in Italian for assessment at RHUL.
- Other work placement: although the School does not undertake to find work placements abroad for students, students themselves, or their families, are sometimes able to make such arrangements, which must be approved by the School. Students in such approved work have similar academic work commitments to those in assistant posts.

The study requirements associated with the Period of Residence Abroad are as follows:

The School of Modern Languages, Literatures and Cultures at Royal Holloway, University of London has a system for assessment of the Period of Residence Abroad to reflect its integral place within the degree programme which involves two course units:

The 13th unit aims to develop intellectual or professional abilities through an experience either working, or studying, in an Italian-speaking country.

The 14th unit aims to further linquistic abilities and cultural awareness through a period of up to one academic year spent living in an Italian-speaking country.

Assessment of the 13th unit

Students are to follow and provide marks for classes, in subjects approved by the School at Royal Holloway, amounting to a minimum of 48 European credits for a full year, and a minimum of 24 European credits for a half year placement. Certain courses in Italian language may count towards these credits. For full details of the conditions applying in respect of such courses see the latest PRA Handbook

Students on a work placement, including assistants, will be assessed by a Work Placement Report. This report will be written in Italian and will discuss aspects of the Period of Residence Abroad relating specifically to the work environment. Students may also be required to write a Cultural Report, in addition to the Work Placement Report. Those spending an entire year in an Italian speaking country on a work place must write a Work Placement Report, and a Cultural Report. Those on half a year work placement can choose between a Work Placement and a Cultural Report.

The 14th unit is assessed by examination to test oral/aural linguistic skills and intercultural awareness.



Section 5 - Educational aims of the programme

The aims of this programme are:

- to produce students who are well prepared with the knowledge and skills to live in and contribute to a rapidly changing international environment;
- to produce students who will graduate with a commitment to continue to improve their knowledge and expand their skills;
- to place questions of European political, economic, social, cultural and linguistic development at the centre of the analysis;
- to foster an understanding of how European political, economic, social, cultural and linguistics developments are inter-related;
- to encourage an interdisciplinary theoretical approach based on these inter-related phenomena;
- to enable you to understand and use the key concepts, approaches and methods of at least one social science and at least one European language /or a comparative literature and culture course, a literature and culture option;
- to develop in you a capacity to think critically about events, ideas and institutions;
- to encourage you to relate the academic study of Europe to guestions of public concern;
- to assist you to develop a range of cognitive and social skills relevant to your intellectual, vocational and personal development;
- to provide a curriculum supported by scholarship, staff development and a research culture that promotes breadth and depth of intellectual enquiry and debate;
- to create a learning environment that is receptive to your needs and views and encourages you to achieve your full potential;



Section 6 - Programme learning outcomes

In general terms, the programmes provide opportunities for students to develop and demonstrate the following learning outcomes. (Categories – Knowledge and understanding (K), Skills and other attributes (S), and Transferable skills (*))

- 1. of the development, workings, policies and limitations of European institutions (K);
- 2. of the major social, political and economic trends in Europe, especially integration **(K)**;
- advanced linguistic competencies in at least one of the following languages –
 French, German, Italian, Spanish or, for the Politics Society and Culture
 pathway, advanced understanding of different aspects of European politics,
 society and culture (K);
- 4. of the cultural and social context of at least one of the major languages mentioned above **(K)**;
- 5. of the major concepts, theories, methodologies and literature of at least one social science (K);
- 6. an ability to apply the major concepts, theories, methodologies and literature of the social science subject(s) to the empirical setting of Europe (K);
- 7. use information to support an argument, hypothesis or proposition (S*);
- 8. present information with high levels of written accuracy (S*);

- 9. transfer linguistic skills to a specialist social science literature (S);
- gather, structure and deploy evidence, data and information from a variety of secondary and some primary sources (S*);
- 11. identify, investigate, analyse, formulate and advocate solutions to problems (S*);
- 12. construct reasoned argument, synthesise relevant information and exercise critical judgement (S*);
- 13. reflect on their own learning and seek and make use of constructive feedback (5*);
- 14. continually analyse and question their own assumptions and those of others (5*);
- 15. demonstrate oral competence and the confidence to use these skills in at least one language additional to the mother tongue (S*);
- 16. use communication and information technology for the retrieval and presentation of information, including, where appropriate, statistical or numerical information (S*);
- 17. engage in theoretical and conceptual debate (S*);
- 18. work independently, demonstrating initiative, self-organisation and time-management (S*);
- 19. collaborate with others to achieve common goals (S*);



Section 7 - Teaching, learning and assessment

Teaching and learning on the programmes draw on the methods and concepts used to investigate political phenomena at both national and international levels. It is also strongly informed by the current research interests of the core teaching team within the Department. The main methods used to develop knowledge and understanding are formal lectures by academic staff within the Department, tutorials and seminar discussions based on a combination of staff led sessions and student presentations.

Assessment will be by a combination of assessed coursework and examination, as indicated in individual course specifications. The aim through the programme is to use a variety of different assessments (essays, examinations, other set coursework, presentations) to gauge your performance in as comprehensive a way as possible. If you are studying Politics and International Relations, the assessment process culminates in guided independent research/study with the production of a dissertation, which is a compulsory course in the final year.

Full details of the assessments for individual courses can be obtained from the <u>Department of Politics and International Relations</u>.

Section 8 – Additional costs

Living costs for your year abroad will vary by country. Typical living costs to consider will be accommodation, food/household items, entertainment, travel, books/equipment and bills (including mobile phone) Students will also need to budget for travel to and from the country of study. Additional costs compared to study in the UK will also depend on personal choices and it is important to research the cost of living before the year commences. Further detail on living costs for year abroad students, by country of study, will be available on the School of Modern Languages, Literatures and Cultures website from January 2016.

These estimated costs relate to studying this particular degree programme at Royal Holloway. General costs such as accommodation, food, books and other learning materials and printing etc., have not been included, but further information is available on our website.
