# 1. Competitive Cash Award Undergraduate Scholarships

## 1.1 Barbara Raw Scholarships for English

Five cash award scholarships are available to new first year undergraduate students from one of the eligible degree courses.

### 1.1.1 Eligibility

These scholarships are open to new undergraduate students applying for one of the following courses:

- a. BA English
- b. BA English and Drama
- c. BA English and History
- d. BA English with Philosophy
- e. BA Music and English
- f. BA English and Film Studies
- g. BA English and Classical Studies
- h. BA English and American Literature
- i. BA English and Creative Writing
- j. BA Modern Languages and English
- k. BA Comparative Literature and Culture and English
- I. BA Drama and Creative Writing

To be considered for this award, applicants must have achieved, or be predicted, high grades at A-level or equivalent. For example, previous applicants have achieved/been predicted AAA or equivalent.

Applicants must also submit a strong scholarship statement.

Successful applicants are normally required to maintain an average academic grade of at least sixty percent to continue to be eligible for the cash award after their first year.

Applicants cannot hold this scholarship in conjunction with the Barbara Raw Scholarship for English Access Scholarship.

#### 1.1.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

## 1.1.3 Payment

This scholarship is awarded as a cash award of £5000 in total, given in instalments over three years of study at Royal Holloway: £3,000 in year 1, £1,000 in year 2 and £1,000 in year 3.

Students on a four- year undergraduate degree who spend their third year on a placement will not receive any scholarship funding for that third year. However, for the fourth year of the undergraduate degree, the cash award will apply.

For students on a four-year course with no external placement or a five-year course with an external placement, the scholarship will be disbursed in the first three years of the degree course only.

### 1.2 Barbara Raw Scholarships for English Access

Two cash award scholarships are available for new first year undergraduate students with home fee status, studying one of the eligible degrees below.

### 1.2.1 Eligibility

These scholarships are open to new first year undergraduate students applying for one of the following courses:

- a. BA English
- b. BA English and Drama
- c. BA English and History
- d. BA English with Philosophy
- e. BA Music and English
- f. BA English and Film Studies
- g. BA English and Classical Studies
- h. BA English and American Literature
- i. BA English and Creative Writing
- j. BA Modern Languages and English
- k. BA Comparative Literature and Culture and English
- I. BA Drama and Creative Writing

Applicants must have Home fee status.

Applicants must also meet the widening access criteria of being in care for more than three months OR two of the following:

- a. Attend an Aspiring School (low performing school) which is named <u>here</u>.
- b. Disability or health condition that impacts their daily life.
- c. Mature student (aged 21 or over at the time of the course start date).
- d. Parents/carers have not attended a university.
- e. Home postcode matches the definition of a lower participation in higher education neighbourhood (POLAR 4, Q1) which is shown here.

To be considered for this award, applicants must have achieved, or be predicted, high grades at A-level or equivalent. For example, previous applicants have achieved/been predicted AAA or equivalent.

Applicants must also submit a strong scholarship statement.

Successful applicants are normally required to maintain an average academic grade of at least sixty percent to continue to be eligible for the cash award after their first year.

Applicants cannot hold this scholarship in conjunction with the Barbara Raw Scholarship for English Scholarship.

#### 1.2.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

#### 1.2.3 Payment

This scholarship is awarded as a cash award of £5000 in total, given in instalments over three years of study at Royal Holloway: £3,000 in year 1, £1,000 in year 2 and £1,000 in year 3.

Students on a four- year undergraduate degree who spend their third year on a placement will not receive any scholarship funding for that third year. However, for the fourth year of the undergraduate degree, the cash award will apply.

For students on a four-year course with no external placement or a five-year course with an external placement, the scholarship will be disbursed in the first three years of the degree course only.

### 1.3 Elaine Etherton scholarship

One cash award scholarship is available to a new first year UK undergraduate student of restricted means with outstanding academic potential.

## 1.3.1 Eligibility

These scholarships are open to new first year undergraduate students applying for a bachelors degree undergraduate course run by one of the following departments:

- a. English
- b. History
- c. Biological Sciences
- d. Earth Sciences
- e. Geography
- f. Psychology
- g. Physics

Applicants must have achieved, or be predicted, AAA at A-level or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must have Home fee status.

Applicants must confirm in the scholarship statement that they have applied or intend to apply for Student Finance.

Applicants have a family income of less than £25,000, as verified by the Student Loans Company (SLC).

Applicants who do not meet the household income criteria for this award will have their scholarship offer withdrawn.

#### 1.3.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be contacted by email once applications have closed to request consent to contact the Student Loan Company to share their household income information and details of their maintenance loan application with the University.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

#### 1.3.3 Payment

This scholarship is offered as a cash award of £3,500 per annum, which in turn is paid in equal termly instalments at the start of each term in October, January, and April, for the first three years of study.

Students on a four- year undergraduate degree who spend their third year on a placement will not receive any scholarship funding for that third year. However, for the fourth year of the undergraduate degree, the cash award will apply.

For students on a four-year course with no external placement or a five-year course with an external placement, the scholarship will be disbursed in the first three years of the degree course only.

# 2. Competitive Cash Award Postgraduate Scholarships

### 2.1 Dinah and Jessica Nichols Scholarship

One cash award scholarship for a new full time or part-time Masters student applying for eligible Masters degrees.

### 2.1.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

- a. MA Holocaust Studies
- b. MA History
- c. MA History: Crusader Studies
- d. MA History: Hellenic Studies
- e. MA History: Public History
- f. MA Late Antique and Byzantine Studies
- g. MA History: Medieval Studies

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK First Class Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must also provide one academic reference.

#### 2.1.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 500 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application and copies of recent transcripts attached to the scholarship application.

Applicants must also provide one academic reference of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

## 2.1.3 Payment

This scholarship is awarded as a cash award of £6,250 in total, given in equal termly instalments, over the period of study at the University.

Full-time students will be paid over three terms (one academic year) and part-time students will be paid over six terms (two academic years).

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

## 2.2 Global Future Leaders Scholarship: USA

One cash award scholarship for a new full time postgraduate students from the US studying any postgraduate taught Masters degree.

### 2.2.1 Eligibility

These scholarships are open to new postgraduate taught Masters offer holders.

Applicants must have Overseas fee status.

Applicants must be United States of America citizens.

Applicants must have achieved, or be expected to achieve, a UK First Class Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 2.2.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

# 2.2.3 Payment

This scholarship is awarded as a cash award of £3,000 in total, given in equal termly instalments, over the period of study at the University.

Full-time students will be paid over three terms (one academic year).

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

## 2.3 Professor Barbara Raw Masters Scholarships for English

Two cash award scholarships for a new full time or part-time Masters student applying eligible courses in the English Department.

# 2.3.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

- a. MA History: Medieval Studies
- b. MA English Literature: Medieval Studies
- c. MA English Literature: Victorian Literature, Art and Culture
- d. MA English Literature
- e. MA Creative Writing

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 2.3.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of a candidate's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

# 2.3.3 Payment

This scholarship is awarded as a cash award of £10,000 in total, given in equal termly instalments, over the period of study at the University.

Full-time students will be paid over three terms (one academic year) and part-time students will be paid over six terms (two academic years).

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

## 2.4 Professor Barbara Raw Scholarship for MA in Medieval Studies

One cash award scholarship for a new full time or part-time Masters student applying for the Medieval Studies pathway.

# 2.4.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

a. MA History: Medieval Studies

b. MA English Literature: Medieval Studies

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 2.4.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

#### 2.4.3 Payment

This scholarship is awarded as a cash award of £10,000 in total, given in equal termly instalments, over the period of study at the University.

Full-time students will be paid over three terms (one academic year) and part-time students will be paid over six terms (two academic years).

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 2.5 The Gent Rust Scholarship

Two cash award scholarships for a new full time or part-time postgraduate students from the UK studying eligible Masters degrees.

# 2.5.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for an MSc with one of the following departments:

- a. Biological Sciences
- b. Computer Sciences
- c. Earth Sciences
- d. Electronic Engineering
- e. Information Security
- f. Physics
- g. Economics
- h. Health Studies
- i. Psychology

Applicants must have Home fee status.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 2.5.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

The donor(s) may be involved in the allocation process of this scholarship.

### 2.5.3 Payment

This scholarship is awarded as a cash award of £8,000 in total, given in equal termly instalments, over the period of study at the University.

Full-time students will be paid over three terms (one academic year) and part-time students will be paid over six terms (two academic years).

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 3. Competitive Tuition Fee Reduction Undergraduate Scholarships

# 3.1 Geoffrey Kneebone Scholarship

Two tuition fee reduction scholarships are available to new first year undergraduate students holding an offer to study Mathematics.

## 3.1.1 Eligibility

These scholarships are open to new first year undergraduate students applying for one of the following courses:

- a. BSc Mathematics
- b. MSci Mathematics

To be considered for this award, students must have achieved, or be predicted, ABB at A-level or equivalent.

Applicants must also submit a strong scholarship statement.

#### 3.1.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

### 3.1.3 Payment

This scholarship is offered as a £1,000 tuition fee reduction for the first year of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year.

### 3.2 Royal Holloway University of London Teaching Centre Excellence Scholarship

Two tuition fee reduction scholarships are available to new international students who are currently studying the Royal Holloway BSc Business Administration course at an eligible University of London Teaching Centre listed below.

Successful applicants will not be eligible for the University of London alumni discount.

### 3.2.1 Eligibility

These scholarships are open to new undergraduate students applying for Second- or Third-year entry onto one of the following courses:

- a. BSc Business and Management
- b. BSc Management with Marketing.
- c. BSc Management with International Business.
- d. BSc Management with Human Resources.

Applicants must be a current student of the Royal Holloway BSc Business Administration at one of the following University of London Recognised Teaching Centres:

- a. Beaconhouse International College (BIC), Pakistan
- b. The Millennium Universal College (TMUC), Pakistan
- c. UCL Business School, Multan / Universal College Lahore (UCL), Pakistan
- d. LGS International Degree Programme (LGS), Pakistan
- e. Denning Law School, Pakistan
- f. Escola Superior de Propaganda y Marketing (ESPM), Brazil
- g. Universidad de Lima, Peru
- h. Saint Martin's Institute of Higher Education, Malta
- i. Russell Square International College, India
- j. University of Seychelles
- k. Euro University of Bahrain
- I. Blackstone School of Law
- m. TILS UCL Business School, Multan

Applicants must have achieved, or be expected to achieve, an average of 65% in their distance learning studies.

Applicants must have Overseas fee status.

Applicants must also submit a strong scholarship statement.

#### 3.2.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

An interim degree transcript for the Royal Holloway BSc Business Administration course must also be provided as part of the scholarship application.

Applicants will be assessed based on academic performance and attendance to date.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

#### 3.2.3 Payment

This scholarship is offered as a £6,000 tuition fee reduction for the first year of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year.

Successful applicants cannot combine their scholarship with the University of London alumni discount.

## 3.3 Sanctuary scholarship

One tuition fee reduction and living costs scholarship is available to new first-year eligible undergraduates in any subject to promote access to Higher Education for students who have fled persecution and sought asylum in the UK.

## 3.3.1 Eligibility

Applicants must meet the following criteria:

- a. Be one of the following:
  - Asylum seeker
  - Child of an asylum seeker
  - Hold Discretionary Leave to Remain
- b. Be ineligible to obtain funding from the Student Loan Company including tuition fee loans, maintenance loans or maintenance grants.
- c. Have the right to study in the UK.
- d. Hold an offer to study an undergraduate course at Royal Holloway, University of London.

Applicants must be able to provide evidence that they have sought asylum on arrival in the UK and that their asylum application is under consideration by the Home Office.

Applicants who have refugee status are not eligible for this scholarship.

Applicants must have Overseas fee status.

Applicants must also submit a strong scholarship statement.

Applicants will remain eligible for the award for three years of their undergraduate degree unless one or both of the following situations occurs:

a. A student (or their parents or spouse/civil partner) is granted indefinite leave to enter/remain in the UK.

b. A student becomes eligible to receive funding from the Student Loan Company (either tuition fee loan or maintenance loan).

If an applicant is no longer eligible and the above circumstances occur, the applicant must inform the University immediately and the award will cease from the start of the next academic year, when they would be expected to apply for student finance instead.

#### 3.3.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 1000 words.

A referee's supporting statement must also be provided as part of the scholarship application.

Applicants must also provide a copy of their immigration documents to evidence their eligibility for the scholarship. Applicants will be contacted by email once applications have closed to request consent to contact UKVI to conduct right to study checks.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

The donor of the maintenance grant may be involved in the allocation process.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

#### 3.3.3 Payment

The scholarship is offered as a full tuition fee reduction available over three years of study at Royal Holloway and a Friendly Hand Maintenance Bursary of £12,000 per annum, paid in equal termly instalments in October, January, and April each academic year.

Students on a three-year undergraduate degree who choose to spend their second year abroad will have any tuition fees owing to Royal Holloway waived by this scholarship. However, no additional cash award will be made in these circumstances.

Students on a four- year undergraduate degree who spend their third year on a study abroad placement will not receive any scholarship funding for that third year. However, for the fourth year of the undergraduate degree, the full tuition fee reduction will apply.

### 3.4 <u>The Red Rose Future Leaders Scholarship</u>

One full tuition fee reduction scholarship for three years is available for a new UK undergraduate student with leadership potential within selected academic departments.

### 3.4.1 Eligibility

These scholarships are open to new first year undergraduate students applying for a bachelors degree undergraduate course run by one of the following departments:

- a. Computer Science
- b. Electronic Engineering
- c. Mathematics
- d. Physics

Applicants must have achieved, or be predicted, AAA at A-level or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must have Home fee status.

Applicants must demonstrate a financial need for this scholarship.

#### 3.4.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

The strength of a candidate's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

## 3.4.3 Payment

This scholarship is offered as a full tuition fee reduction available over three years of study at Royal Holloway.

Students on a four- year undergraduate degree who spend their third year on a placement will not receive any scholarship funding for that third year. However, for the fourth year of the undergraduate degree, the cash award will apply.

For students on a four-year course with no external placement or a five-year course with an external placement, the scholarship will be disbursed in the first three years of the degree course only.

# 3.5 University of London scholarship

One tuition fee reduction scholarship is available for an eligible full-time undergraduate student with Home fee status, who meets the eligibility criteria listed below. The scholarship is provided as a tuition fee reduction and contribution to living costs to the value of £10,000 a year, for three years of study.

### 3.5.1 Eligibility

These scholarships are open to new first year undergraduate students who hold an offer to study an undergraduate course at Royal Holloway, University of London.

To be considered for this award, applicants must have achieved, or be predicted, high grades at A-level or equivalent. For example, previous applicants have achieved/been predicted AAA or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must have Home fee status.

Applicants must be currently resident in a London borough as defined by Ordnance Survey Election Maps (<a href="https://www.ordnancesurvey.co.uk/election-maps/gb/">https://www.ordnancesurvey.co.uk/election-maps/gb/</a>).

Applicants must identify as one of the following:

- a. being from a racially minoritised, or global majority background (including but not limited to Black, Asian, minoritised ethnic and/or from a multiracial background).
- b. Being estranged or having lived in local authority care

#### 3.5.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 150 words.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

### 3.5.3 Payment

This scholarship is offered as a tuition fee reduction of £10,000 per annum, which in turn is paid in equal termly instalments at the start of each term in October, January, and April.

If the tuition fee for the chosen course is less than £10,000, the remainder will be paid as a cash award to be used as a contribution to living costs.

# 4. Competitive Tuition Fee Reduction Postgraduate Scholarships

# 4.1 <u>Bedford Society Scholarship</u>

Three tuition fee reduction scholarships are available for any student studying a taught Masters degree with any eligible department. One scholarship is allocated to each of the following schools: School of Humanities, School of Life Sciences and the Environment and School of Law and Social Sciences.

## 4.1.1 Eligibility

These scholarships are open to new postgraduate taught Masters students applying for a Masters degree with one of the following departments:

a. Department of Classics

- b. Department of English
- c. Department of History
- d. Department of Languages, Literatures and Cultures
- e. Department of Economics
- f. Department of Law and Criminology
- g. Department of Politics, International Relations, and Philosophy
- h. Department of Social Work
- i. Department of Health Studies
- j. Department of Earth Sciences
- k. Department of Geography
- I. Department of Psychology
- m. Department of Mathematics
- n. Department of Physics

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK First Class Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 4.1.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

## 4.1.3 Payment

This scholarship is offered as a tuition fee reduction of £8,100.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split over their first two years of study only.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.2 <u>Bradley de Glehn English Scholarship</u>

One tuition fee reduction scholarship up to £9,600 for eligible taught postgraduate degrees within the Department of English.

### 4.2.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

- a. MA English Literature: Medieval Studies
- b. MA English Literature: Victorian Literature, Art and Culture
- c. MA English Literature
- d. MA Creative Writing

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must also provide one academic reference.

#### 4.2.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants must also provide one academic reference of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

## 4.2.3 Payment

These scholarships are offered as a tuition fee reduction of £9,600.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split over their first two years of study only.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.3 <u>Bradley de Glehn Philosophy Scholarship</u>

One tuition fee reduction scholarship for taught postgraduate degrees within the Department of Philosophy for a full or part-time postgraduate student with Home or Overseas fee status.

### 4.3.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

- a. MA European Philosophy
- b. MA Political Philosophy

Applicants must have Home or Overseas fee status.

Applicants must also submit a strong scholarship statement.

Applicants must also provide one academic reference.

#### 4.3.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 500 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

Applicants must also provide one academic reference of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

## 4.3.3 Payment

This scholarship is offered as a tuition fee reduction of £9,600.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split evenly over their first two years of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year for full-time students, or longer than two years for part-time students.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.4 Brian Harris Scholarship

Two tuition fee reduction scholarships for UK students applying for eligible Humanities or Business and Management postgraduate degrees who have studied a Humanities degree at undergraduate level.

- n. MSc Accounting and Financial Management
- o. MSc AI for Business
- p. MSc Digital Marketing
- q. MSc Entrepreneurship and Innovation
- r. MSc Entrepreneurship and Innovation with a Year In Business
- s. MSc Human Resource Management
- t. MSc International Business Management
- u. MSc Marketing

Applicants must have Home fee status.

Applicants must demonstrate financial need for the scholarship.

Applicants must be awarded, or expect to be awarded, an undergraduate degree in a Humanities subject.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must also provide two academic references.

Applicants must also provide an up-to-date CV.

Applicants must also provide an example of work from their undergraduate degree.

#### 4.4.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 100 words per question (800 words overall).

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application and copies of recent transcripts attached to the scholarship application.

Applicants must also provide two academic references of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

Applicants must provide evidence of the financial support received at undergraduate level and the basis on which this was received and why. Acceptable sources of evidence could include Student Finance England, Student Awards Agency Scotland, Student Finance Wales, Student Finance Northern Ireland, University funded bursary, where this has been awarded on the basis of financial need.

Applicants will also be assessed on the piece of undergraduate work they are most proud of and their up-to-date CV.

The donor(s) may be involved in the allocation process of this scholarship.

### 4.4.3 Payment

This scholarship is offered as a tuition fee reduction of £10,000 only.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split evenly over their first two years of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year for full-time students, or longer than two years for part-time students.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.5 Corky McGuinness Award in Musicology

One tuition fee reduction scholarship for any new full-time postgraduate student applying for MMus Music.

These scholarships are open to new postgraduate Masters students applying for MMus Music.

Applicants must have Home or Overseas fee status.

Applicants must be applying for full-time study.

Applicants must have achieved, or be expected to achieve, a UK First Class Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

#### 4.5.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application.

### 4.5.3 Payment

This scholarship is offered as a tuition fee reduction of £4,000.

This will apply in their first year of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

### 4.6 <u>David Cesarani Scholarship</u>

One tuition fee reduction and contribution towards living costs, if applicable, to the value of £11,000 for MA Holocaust Studies for a new full-time or part-time student with Home or International fee status.

# 4.6.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for MA Holocaust Studies.

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK First Class Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must also provide one academic reference.

#### 4.6.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 500 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application and copies of recent transcripts attached to the scholarship application.

Applicants must also provide one academic reference of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

### 4.6.3 Payment

This scholarship is offered as a tuition fee reduction of £11,000. If the tuition fee for the chosen course is more than £11,000, this award will be made as a £11,000 tuition fee reduction only. If the tuition fee for the chosen course is less than £11,000, the remainder will be paid as a cash award to be used as a contribution to living costs.

If a cash award is applicable, it will be paid in equal termly instalments as a contribution towards living costs.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split evenly over their first two years of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year for full-time students, or longer than two years for part-time students.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.7 David Cesarani, Kobler Scholarship

One tuition fee reduction and contribution towards living costs, if applicable, to the value of £10,000 for MA Holocaust Studies for a new full-time or part-time student with Home or International fee status.

# 4.7.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for MA Holocaust Studies.

Applicants must have Home or Overseas fee status.

Applicants must have achieved, or be expected to achieve, a UK 2:1 Honours Bachelors degree or equivalent.

Applicants must also submit a strong scholarship statement.

Applicants must also provide one academic reference.

#### 4.7.2 Allocation

Students must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 500 words.

Applicants will be scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

The strength of an applicant's previous academic background will also be considered. This will be assessed via the documents submitted as part of their degree application and copies of recent transcripts attached to the scholarship application.

Applicants must also provide one academic reference of up to 200 words (on official headed paper) which should be emailed to <a href="mailto:rhps@rhul.ac.uk">rhps@rhul.ac.uk</a> before the scholarship application deadline.

#### 4.7.3 Payment

This scholarship is offered as a tuition fee reduction of £10,000. If the tuition fee for the chosen course is more than £10,000, this award will be made as a £10,000 tuition fee reduction only. If the tuition fee for the chosen course is less than £10,000, the remainder will be paid as a cash award to be used as a contribution to living costs.

If a cash award is applicable, it will be paid in equal termly instalments as a contribution towards living costs.

For full-time students, this will apply in their first year of study only. For part-time students, this will be split evenly over their first two years of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year for full-time students, or longer than two years for part-time students.

Successful applicants will not be eligible for any other tuition fee reduction scholarship or discount.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

# 4.8 Dr Pirkko Koppinen Scholarship

One tuition fee reduction scholarship for any new postgraduate student applying for the Medieval Studies pathway. The scholarship is provided as a tuition fee reduction and contribution to living costs, if applicable, to the value of £12,000 a year.

# 4.8.1 Eligibility

These scholarships are open to new postgraduate Masters students applying for one of the following courses:

- a. MA History: Medieval Studies
- b. MA English Literature: Medieval Studies

- c. Recognised partnership discounts not including the progression fee discount which is available to all progressing RHISC students.

Successful applicants cannot combine their scholarship with the 10% progression fee discount which is available to all progressing RHISC students.

Successful applicants who interrupt in the first year of study for which they have received the tuition fee reduction, will have the scholarship pro-rated.

# 6. <u>Automatic Tuition Fee Reduction Postgraduate Scholarships</u>

# 6.1 Royal Holloway India Postgraduate Scholarship

Scholarships are available to all new postgraduate full-time students who are ordinarily resident within India.

# 6.1.1 Eligibility

Applicants must have Overseas fee status.

Applicants must be ordinarily resident in India at the point of their application for postgraduate study.

These scholarships are open to new postgraduate students who hold an offer to study a full-time Masters degree course at Royal Holloway, University of London for the September or January entry of the next academic year. Deferred offers and applications for academic years after the next immediate academic year are not eligible.

Applicants must be self-funded.

Applicants must pay their tuition fee deposit by the stipulated deadline on the scholarship webpage.

Applicants must complete their studies in person at one of the Royal Holloway campuses in the UK.

#### 6.1.2 Allocation

Scholarships will be automatically allocated.

Ordinary residency will be assessed via the documents submitted as part of their degree application.

No additional scholarship application is required.

#### 6.1.3 Payment

This scholarship is offered as a £6,000 tuition fee reduction for the first year of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year.

Successful applicants cannot combine this scholarship with the following financial awards:

- a. Tuition fee reduction and/or discount
- b. Internal scholarship cash award
- c. Recognised partnership discounts including the progression fee discount which is available to all progressing RHISC students.

Applicants who are eligible for or are considered for more than one scholarship, will be awarded the scholarship or discount with the highest monetary value. If an applicant is eligible for scholarships of equal monetary value, the applicant will be awarded the competitive scholarship.

All payments, discounts and fee reductions will only be made providing the student is enrolled at Royal Holloway on a postgraduate degree course at the time of the payment.

Successful applicants who interrupt in the first year of study for which they have received the tuition fee reduction, will have the scholarship pro-rated.

# 7.7 Royal Holloway International Study Centre (RHISC) Excellence Scholarship

Ten tuition fee reduction scholarships are available to new international students progressing onto degrees from the International Foundation Year, International Year 1, or Pre-Masters Programme at Royal Holloway International Study Centre (RHISC).

Successful applicants can combine their scholarship with a 10% progression fee discount which is available to all progressing RHISC students.

Applications will be considered from any applicant who has completed one of the above courses at the RHISC in the academic year prior to their progression onto their Royal Holloway degree programme.

### 7.7.1 Eligibility

Applicants must be self-funded and have a current undergraduate or postgraduate offer to study a degree programme at the University.

Applicants must be classified by the RHISC (Royal Holloway, International Study Centre) as 'Green' or 'Amber' in the RHISC Academic Progression Report (RPAG, Red/Pink/Amber/Green).

Applicants must also have 85% attendance or above during their International Foundation Year, International Year 1, or Pre-Masters at the RHISC.

#### 7.7.2 Allocation

Applicants must submit a completed scholarship application form by the deadline, specified annually. The scholarship supporting statement must be no longer than 400 words.

Applicants will be assessed based on academic performance and attendance to date.

Applicants will be also scored on how effectively the scholarship supporting statement responds to the criteria given on the scholarship webpage.

Applicants from all cohorts of the current academic year will be considered for scholarships awarded for degree programmes beginning the next academic year.

## 7.7.3 Payment

This scholarship is offered as a £3,000 tuition fee reduction for the first year of study only. No additional payment is offered in any following years if the duration of the programme is longer than one year.

Successful applicants can combine their scholarship with a 10% progression fee discount which is available to all progressing RHISC students.

# 7.8 Sports Scholarship

Competitive scholarships are available to student athletes in a recognised sport.
